Good Evening Timmins Diocesan Executive and Presidents,

***Early on the first day of the week, while it was still dark, Mary Magdalene came to the tomb and saw that the stone had been removed from the tomb. John 20:1***

**Happy Easter!** How wonderful it was to be able to participate at our parishes in the Holy Week Celebrations. Not being able to do so last year made this year more moving. The pandemic is still with us and has made all levels of The Catholic Women's League of Canada make changes to their conventions.

Both the National and Provincial Conventions will be held virtually. The decision was made because of the virtual conventions to not bring resolutions forward until 2022. An essential part of the life of a resolution, is the ability to debate and discuss the resolutions at the conventions and then vote to adopt or not. Instead of seeing this as a setback for any resolutions, councils that have a resolution could use this time to review. Is the wording and resolution concise and to the point? Is the resource material used for the brief up to date and from reputable institutions or organizations? Are the main resources used Canadian? Any resolutions brought to the federal or provincial levels of government need to have Canadian content. These are important points to review to make sure your resolution successfully moves through the various levels of the League.

Thank you to all who took the time to complete the annual report for the resolution position. Many councils do not have a member in this position but still find ways to communicate to their members about resolutions. Through resolutions we bring about social justice for those who have no voice and are vulnerable. All efforts to keep our members aware of the importance of our resolutions and how fortunate the League is to bring these resolutions to government is appreciated.

**Inserted below is the National Resolution Chair, Cathy Bouchard Communique of April 2 2021**

"Resolutions play a major part in the League's work. Through them, policy may be established, programs planned, or concerns and views expressed to governments." (*Resolutions Supplement to the Executive Handbook*) It is important that as many members as are able and wish to participate in adopting resolutions are present when a resolution is presented and discussed.

The 2020 annual general meetings for diocesan, provincial and national council will be held in combination with the 2021 conventions. At the 2021 combination of virtual and in-person annual meetings, members will only consider necessary business. Resolutions will not be presented. Any resolutions, unless they are urgent, will be deferred to 2022. Deferring resolutions that move through the different levels of the League gives the opportunity to allow for the full participation of interested members. If a parish council adopted a resolution at its level in 2020, directed to another level of the League, the process will continue in 2022.

**Question:** In 2020, a parish council began a resolution regarding loneliness. The council that created this would like to include new information that has arisen from the COVID-19 pandemic. As this resolution was not brought forward to a diocesan convention, it is still the parish council's property. After the council changes its original resolution, the resolution can be submitted with all the information for 2022.

The parish council can amend the motion (resolution) within its council.

- The motion to rescind is used to cancel a motion altogether.
- The motion to amend something previously adopted is used to change a motion (resolution) either by making a simple change or two or by substituting something else in its place. In the case of this parish council's resolution, the council would want to amend something previously adopted.

Possible wording of this motion could be: "I move to amend the motion Resolution 2020.01 Action on Loneliness..."

- by inserting (or adding, if placing at the end) words, sentences, or paragraphs
- by striking out words, sentences, or paragraphs
- by striking out and inserting words (with the words inserted replacing the words struck out)
- by amending by substitution (a form of strike out and insert applied to paragraphs or entire motions)

Rules for this motion:

- may be proposed only when no other motion is pending
- must be seconded
- may be debated

After the motion has been seconded, the debate can begin, saying why the resolution should be changed. For example, that members would like to include new information that has arisen by the COVID-19 pandemic.

If the council wishes to change the brief of its resolution, no motions to make a change need to be made. Members vote on the actual resolution clause itself, not the brief or action plan.

### **Vote requirements**

Three possible variations of vote requirements allow a council to amend something previously adopted:

- **Two-thirds vote without previous notice**

- **Majority vote with previous notice:** If a member has given notice that she will make the motion at the next meeting, it can be adopted by a majority vote.
- **Majority of the entire membership:** In a situation in which there is no notice, a motion to amend something previously adopted can be adopted if it receives the affirmative vote of a majority of the entire membership.

Suppose a council has 15 members, and 13 are present at the meeting. If all 13 vote, a two-thirds vote would require nine votes, but a majority of the entire membership is only eight. Sometimes, it is easier to achieve a majority of the entire membership than to get a two-thirds vote.
